### **Full Value Contract**

Below is an overview of the Full Value Contract.

#### **1. Safety, Safety, Safety**

Our number one concern is safety. That's why it is listed three times! There are two kinds of safety; physical and emotional safety. We will do everything possible to keep our participants from experiencing physical and / or emotional damage.

⇒ Give and receive feedback. Realize that your input is important. Group processing does not work without everyone committing to participate and communicate your insights for the good of the group.

⇒ Do NOT put yourself down. Do not make statements like, "I can't do this."

⇒ Do NOT put others down. Be positive in your comments. This requires no additional explanation.

⇒ Stay with your group.

⇒ Learn from your mistakes.

#### **2. Challenge by Choice**

Each participant selects the level of challenge that he or she is willing to experience. We will encourage participants to expand their comfort zones without pushing too far.

#### **3. Give 100%**

Each participant agrees to give 100% effort.

I elect to participate and / or allow my child to participate in spite of these risks.

Therefore, for myself / my child, I knowingly and voluntarily assume all risks involved in my / my child's participation, and do hereby release Wildwood Ranch / Detroit Rescue Mission Ministries and it's members, trustees, officers, employees, independent contractors and agents from all liability, damages, costs and expenses arising out of or relating to bodily or psychological injury, loss of life or personal property that may occur as a result of participating in this program.

I have read and understand and accept the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon all parties during the entire period of participation in the said program.

I grant Wildwood Ranch and persons acting through them, the right to use, reproduce, assign, and/or distribute photographs, films, videotapes, and sound recordings of myself or my child for use in materials they may create.
